WORK SESSION (6:00 PM)

1. PLANNING COMMISSION CANDIDATE INTERVIEWS

Council asked the candidates three questions. 1. Please tell us a little about yourself and why you would like to serve on Planning Commission, 2. What do you think are the three biggest planning issues facing the City today, and 3. Do you see any problems with the time preparing for or attending Planning Commission meetings on a regular basis?

Below is a brief summary of the candidate's responses.

Thomas Hoffman

1. To serve and be part of helping to make, and keep, Fairview the best it can be.
2. How to expand the City and provide the community what they want. Provide support to schools. Provide low cost, high value housing.
3. Will need to make schedule adjustments, but is willing to do so.

John Scheelar

1. Has always been active in the community he has lived in. Wants to continue doing so. Be connected to the community.
2. Bridge the division between the different areas of the City; build the relationship and image of one City. Highways and infrastructure. Communication - involving the community in the future of Fairview.
3. No time issues. Committed to the required tasks and meeting schedule.

City Administrator Young inquired if Council would like to extend the COVID-19 Relief Program which expired August 31. He noted the City is eligible for reimbursement through the CARES Act for applicants receiving funds by check, instead of a utility credit. Council supported continuing the program for two months; October 31, 2020.

Councilor Kudrna moved to adjourn the meeting and Councilor Bhullar seconded. The motion passed, and the meeting adjourned at 7:04 PM.


