**A RESOLUTION OF THE FAIRVIEW CITY COUNCIL AUTHORIZING AND
DIRECTIONG THE CITY ADMINISTRATOR TO SIGN AMENDMENT NO. 2 TO
THE NETMOTION SERVER INTERGOVERNMENTAL AGREEMENT BETWEEN
FAIRVIEW AND THE CITY OF GRESHAM**

WHEREAS, the City of Fairview entered into an intergovernmental agreement with the City of Gresham on WHAT DATE (IGA) to allow Fairview to access the City of Gresham's NetMotion server which allows the Fairview Officers' mobile data terminals to connect with the Bureau of Emergency Communications (BOEC); and

WHEREAS, the IGA with East County jurisdictions provides a broadband solution for the VCAD system; and

WHEREAS, this collaboration provides for the police department to have a reliable connection to BOEC at a cost savings to the City; and


WHEREAS, the City desires to continue this partnership.

**NOW, THEREFORE, BE IT RESOLVED BY THE FAIRVIEW CITY COUNCIL AS
FOLLOWS:**

Section 1 The City Administrator is authorized and directed to sign Amendment No. 2 and any necessary extensions or additional amendments, to the NetMotion Server IGA in substantially the same form as the attached Exhibit A.


Section 2 This Resolution is and shall be effective from and after its passage by the Council.

Amendment No. 2

This Contract Amendment is entered into by and between the City of Gresham, a municipal corporation of the State of Oregon (Gresham) and the City of Fairview (Contractor) and amends the contract on file with the Gresham City Recorder as Contract No. 5547 (Contract).

Whereas the City and Contractor desire to extend the contract for an additional year.
