**First Amendment  
Interim City Administrator Temporary Employment Contract**

This is the First Amendment to the Temporary Employment Contract by and between the City of Fairview (City) and Christy Wurster (Employee) executed on June 25, 2015 (Contract).

**RECITALS**

**WHEREAS**, the City Council desires to amend the Contract to allow the Employee to appoint and remove employees to ensure the effective administration of the City; and

**WHEREAS**, the Employee agrees to this amendment to the Contract.

In consideration of the mutual promises contained herein and other good and valuable consideration, the receipt and sufficiency is hereby acknowledged, the Parties agree to the amendments to the Contract as set forth below.

**TERMS**

- 1. Section 4** of the Contract is revised as follows (deletions in strikethrough):

“Employee shall report to the City Council in the carrying out and implementation of her duties. Employee will have the authority granted the City Administrator by Fairview City Charter Section 23 and under Chapter 2.10 of the Fairview Municipal Code ~~except that Employee may only appoint or remove employees with Council approval.~~

- 2. Exhibit A** of the Contract is revised to remove the second paragraph as follows (deletions in strikethrough):

~~“As set forth in Section 4 of this Contract, Employee may appoint or remove employees only with the City Council approval.”~~

The Contract as hereby amended is in full force and effect. Except as expressly modified by this Amendment, the terms, provisions, covenants, and conditions of the Contract shall remain unchanged and are hereby ratified and confirmed as being in full force and effect. In the event of any conflict or inconsistency between the terms of this Amendment and the Contract, the terms of this Amendment shall control.

The parties have executed this Amendment effective as of the last date of signature specified below.
