**A RESOLUTION OF THE FAIRVIEW CITY COUNCIL AMENDING AN  
INTERGOVERNMENTAL AGREEMENT WITH MULTNOMAH COUNTY  
SHERIFF'S OFFICE TO CONTINUE STAFFING AND OPERATIONS AT THE  
GRESHAM TEMPORARY HOLDING FACILITY**

**WHEREAS**, Multnomah County relies on the cities of Gresham and Fairview for financial support to operate the Gresham Temporary Holding Facility located at the Gresham Police Department without a cost share agreement; and

**WHEREAS**, if the City does not participate in the cost share agreement, Fairview Police Department officers would need to transport in custodies to downtown Portland requiring time away from Fairview; and

**WHEREAS**, the City of Fairview previously entered into an IGA for services in FY 2013-14 in the sum of \$2,133 and FY 2014-15 in the sum of \$4,266; and

**WHEREAS**, the proposed cost to Fairview for Fiscal Year 2015-16 is \$4,421; and

**WHEREAS**, Fairview City Council determines it is in the City's best interest to continue to participate in the IGA with Multnomah County for use of the Temporary Holding Facility as proposed.

**NOW, THEREFORE, BE IT RESOLVED BY THE FAIRVIEW CITY COUNCIL AS FOLLOWS:**

**Section 1** The Fairview City Council hereby authorizes the Interim City Administrator to sign the amendment to the Intergovernmental Agreement with Multnomah County to continue staffing and operations of the Gresham Temporary Holding service located at the Gresham Police Department in the amount of \$4,421 for FY 2015-16, on behalf of the City of Fairview substantially in the form attached hereto as Exhibit A.

**Section 2** This resolution is and shall be effective from and after its passage by the City Council.

*(Amendment to change Contract provisions during contract term.)*

Contract Number 201415

This is an amendment to Multnomah County's Contract referenced above effective July 1, 2015 between Multnomah County, Oregon, hereinafter referred to as County, and the Cities of Gresham and Fairview, hereinafter referred to as Contractors.

The parties agree:

1. The following changes are made to Contract No. 201415:  
The Contractors agree to pay for the costs of Gresham Temporary Holding as follows:
  - a. In Fiscal Year 2016:
    - i. City of Gresham will pay the total amount of \$ 68,828.
    - ii. City of Fairview will pay the total amount of \$ 4,421.
    - iii. Multnomah County Sheriff's Office will pay the total amount of \$93,606 as part of Troutdale Law Enforcement Services Intergovernmental Agreement # 201491.
2. All other terms and conditions of the contract shall remain the same.
