**A RESOLUTION OF THE FAIRVIEW CITY COUNCIL AUTHORIZING THE
INTERIM CITY ADMINISTRATOR TO EXECUTE AN AMENDMENT TO AN
INTERGOVERNMENTAL AGREEMENT WITH THE CITY OF GRESHAM
EXTENDING THE PROVISION OF CODE COMPLIANCE SERVICES**

WHEREAS, the City of Fairview entered in to An Intergovernmental Agreement with the City of Gresham on June 24, 2013 (IGA) for Gresham to perform code compliance services; and

WHEREAS, the City previously extended the IGA through an Amendment No.1 on 2014 which revised the hourly compensation rates and extended it through an additional year; and

WHEREAS, the City wishes to extend the IGA for an additional year with revised compensation rates through Amendment No. 2; and

WHEREAS, the City of Gresham has the capacity to continue to provide these code compliance services.

**NOW, THEREFORE, BE IT RESOLVED BY THE FAIRVIEW CITY COUNCIL AS
FOLLOWS:**

Section 1 The Fairview City Council hereby authorizes the Interim City Administrator to enter into Amendment No. 2 to the IGA with Gresham in substantially the same form as the attached Exhibit A.

Section 2 This resolution is and shall be effective from and after its passage by the City Council.


