**2. CITIZENS SPEAK ON NON AGENDA ITEM**

Bob Wade, Fairview, OR spoke regarding the Fairview Municipal Code that requires vehicles be registered to the resident of the property where they are parked and the limits for service and repair of vehicles at a residence. He noted receiving a parking ticket for an unregistered vehicle that he could not park in his driveway. The vehicle is unregistered because it cannot pass DEQ.
