

**Program Criteria** (Mark all that apply)

1.  Development creates jobs
2.  The ground floor space of buildings with street frontage, in a mixed use development, shall be for commercial use.
3.  Development mitigates current and future environmental or storm water issues on the project site or in the urban renewal area.
4.  Development improves traffic or pedestrian infrastructure challenges in the urban renewal area.
5.  Development decreases the number of defunct or derelict structures in the urban renewal area. Grant dollars must be used to cover the cost of structure demolition.
6.  Development decreases the number of vacant or under-utilized lots in the urban renewal area.

Grant dollars must be used for an eligible activity (see Table D)

- 7.  Converts existing first floors in the Village Mixed Use Zone to commercial use. Grant dollars may be used for structural and/or fire safety improvements required to convert the residential structure type to commercial occupancy, and to make tenant improvements.
- 8.  Space improvements for eating and drinking establishments (including purchase of commercial kitchen equipment) in the Village Mixed Use and Town Center Commercial Zones along Halsey Street.

**The Following Items Are Required Before A Grant Project Can Begin:**

1. Certificate of approval from agency (if required).
2. Evidence that land will have been obtained if required.
3. Evidence that any needed building permits or any other required permits are in place.
4. Preliminary commitment of any other funds to be used in the project.
5. Three tentative licensed and bonded contractors or the consultants for projects over \$5,000.
6. A summary of the project outlining the work to be done.
7. Complete plans and specifications.(If applicable)
